### MEMORANDUM OF OPTION AGREEMENT

This Memorandum of Option ("**Memorandum**") is made this 5<sup>th</sup> day of May, 2015 by and between **Barbara F. Harris**, a single/married person (together with its/his/her/their executors, representatives, heirs, successors and assigns hereunder, "**Owner**"), and Ford County Wind Farm LLC, a Delaware limited liability company (together with its successors and assigns hereunder, "**Optionee**").

#### RECITALS

A. Owner owns all that certain real property located in Ford County, Illinois as more particularly described in the attached **Exhibit A**, which is incorporated by this reference ("**Property**").

B. Owner and Optionee have entered into that certain unrecorded Option Agreement dated as of the date hereof ("**Agreement**"), pursuant to which Owner has granted an option to Optionee to purchase an exclusive easement (the "**Easement**") on, along, over, under and across a portion of the Property upon the terms and conditions set forth therein.

C. Owner and Optionee desire to execute this Memorandum and cause the same to be recorded with the Register of Deeds in and for Ford County, Illinois, for the purpose of memorializing the Agreement and to provide third parties with record notice of the existence of the Agreement and Optionee's rights thereunder.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Owner and Optionee hereby acknowledge and agree as follows:

1. Subject to and on the terms and conditions set forth in the Agreement, effective as of the 5<sup>th</sup> day of May, 2015 ("**Effective Date**"), the Owner grants to Optionee an option

(the “**Option**”) to purchase the Easement. The Option continues in full force and effect for a period of five (5) years from the Effective Date.

2. Should Optionee exercise the option to purchase as set forth in the Agreement, Optionee shall purchase from Owner and Owner shall sell to Optionee the Easement, upon the terms and conditions set forth in the Agreement.

3. The sole purpose of this Memorandum is to place the public on notice of inquiry as to existence of the Agreement and to incorporate by reference all of its terms, covenants and conditions to the same extent as if the Agreement were fully set forth herein, and this Memorandum is subject to all of the terms, conditions and provisions of the Agreement.

4. Owner acknowledges and agrees that the Agreement is binding upon Owner and that Property is subject to the rights of Optionee under the Agreement.

5. Owner acknowledges that the Agreement is presently in the full force and effect and is unmodified.

6. In the event of any inaccuracy in the description of the Property, Easement Evaluation Area, or Easement Area, or in the description of the parties in whom title to the Property is vested, Owner and Optionee shall amend this Memorandum to correct such inaccuracy in order to accomplish the intent of Owner and Optionee.

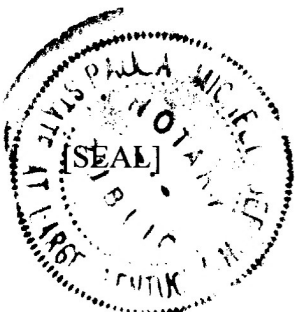



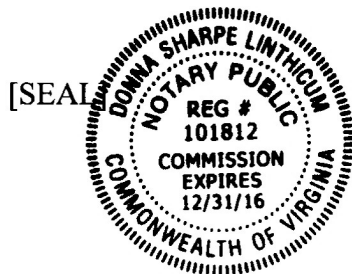

**MEMORANDUM OF**  
**FIRST AMENDMENT TO OPTION AGREEMENT**

This Memorandum of First Amendment to Option Agreement ("**Memorandum**") is made this 21<sup>st</sup> day of April, 2020, by and between Barbara F. Harris, a married person (together with their executors, representatives, heirs, successors and assigns hereunder, "**Owner**"), and Ford County Wind Farm LLC, a Delaware limited liability company (together with its successors and assigns, "**Optionee**").

RECITALS

A. Owner owns all that certain real property located in Ford County, Illinois as more particularly described in Exhibit A attached to the Agreement and attached hereto, which is incorporated by this reference ("**Property**").

B. Owner and Optionee entered into that certain Option Agreement dated as of May 5, 2015, a Memorandum of which was recorded in the official records of Ford County, Illinois (the "**Official Records**") on June 15, 2015 as Document Number 261959; and Owner and Optionee have entered into that certain First Amendment to Option Agreement (the "**First Amendment**") of even date herewith (as amended, the "**Agreement**"), pursuant to which Owner has granted an option to Optionee to purchase an exclusive easement (the "**Easement**") on, along, over, under and across a portion of the Property upon the terms and conditions set forth therein.

C. Owner and Optionee desire to execute this Memorandum and cause the same to be recorded in the Official Records, for the purpose of memorializing the First Amendment and Optionee's rights thereunder.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledge, Owner and Optionee hereby acknowledge and agree as follows:

1. Subject to and on the terms and conditions set forth in the First Amendment, the Option Period is hereby amended to be ten (10) years from the Effective Date.
2. Should Optionee exercise the option to purchase as forth in the Agreement, Optionee shall purchase from Owner and Owner shall sell to Optionee the Easement, upon the terms and conditions set forth in the Agreement, amended by the First Amendment.
3. The sole purpose of this Memorandum is to place the public on notice of inquiry as to the existence of the Agreement, as modified by the First Amendment, and to incorporate by reference all of its terms, covenants and conditions to the same extent as if the First Amendment were fully set forth herein, and this Memorandum is subject to all of the terms, conditions and provisions of the Agreement and the First Amendment.
4. Owner acknowledges and agrees that the Agreement is binding upon Owner and that Property is subject to the rights of Optionee under the Agreement.
5. Owner acknowledges that the Agreement, as modified in the First Amendment, is presently in the full force and effect, Capitalized terms used but not defined herein, shall have the meaning ascribed to such terms in the Agreement.
6. In the event of any inaccuracy in the description of the Property, Easement Evaluation Area, or Easement Area, or in the description of the parties in whom title to the Property is vested, Owner and Optionee shall amend this Memorandum to correct such inaccuracy in order to accomplish the intent of Owner and Optionee.

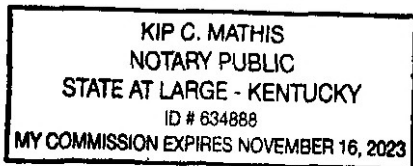

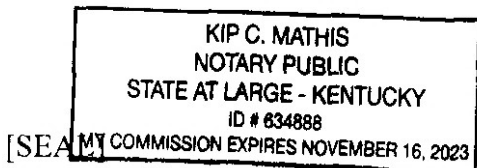

### **ASSIGNMENT AND ASSUMPTION AGREEMENT**

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT (this "**Agreement**") is made to be effective as of November 23, 2020 (the "**Effective Date**") by and between FORD COUNTY WIND FARM LLC, a Delaware limited liability company, ("**Assignor**"); and SIBLEY WIND, LLC, a Delaware limited liability company ("**Assignee**"). Assignor and Assignee shall collectively be referred to herein as the "**Parties**".

#### **RECITAL:**

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in, to and under those certain easements set forth on Exhibit A attached hereto (collectively, the "**Assigned Easements**"), and Assignee desires to accept said assignment and assume the obligations of the Assignor set forth in the Assigned Easements, as assigned, and subject to the terms, covenants and conditions set forth in this Agreement.

#### **AGREEMENT:**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. Assignment. As of the Effective Date, Assignor hereby assigns, transfers, sets over and conveys unto Assignee (the "**Assignment**") all of Assignor's right, title and interest as lessee and/or grantee in, to and under the Assigned Easements, as assigned.

2. Assumption. As of the Effective Date, Assignee hereby accepts the Assignment and assumes all obligations of Assignor under the Assigned Easements, as assigned, to the extent such obligations arise or accrue on or after the Effective Date.

3. Governing Law. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Illinois, without regard to the conflicts of laws principles thereof.

4. Binding Effect. This Agreement shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns.

5. Entire Agreement. This Agreement contains the entire agreement between the Parties with respect to matters set forth herein, and all prior negotiations, understandings and agreements (including, but not limited to, any letter of intent executed by the Parties) are superseded by this Agreement. No modification of this Agreement (including waivers of rights and conditions) shall be effective unless in writing and signed by the Party against whom enforcement of such modification is sought, and then only in the specific instance and for the specific purpose given.

6. Headings. Article and section headings are included in this Agreement for convenience of reference only and shall not be used in construing this Agreement.

7. Multiple Counterparts. This Agreement may be executed in two or more counterparts, all of which shall be considered one and the same agreement and each of which shall be deemed an original.

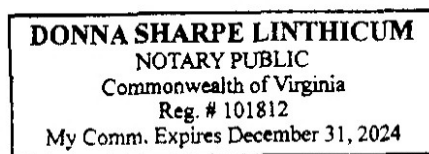

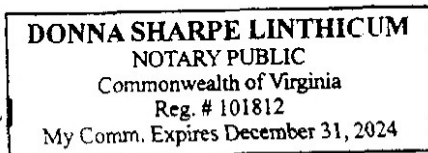
